CONVERGENCE Two species that evolved from the same ancestor but adapted to different environments.	DIVERGENT EVOLUTION Two species that evolved from the same ancestor but adapted to different environments.
ADAPTATION A trait that helps an organism survive in its environment.	PUNCTUATED EQUILIBRIUM Evolution occurs in rapid bursts followed by long periods of stability.
STABILIZING SELECTION A type of natural selection that favors the average phenotype and selects against extreme traits.	SPECIATION The process by which new species are formed from existing ones.
DISRUPTIVE SELECTION A type of natural selection that favors extreme phenotypes and selects against the average phenotype.	ADAPTIVE RADIATION The rapid evolution of many species from a single ancestor to fill different ecological niches.
